Leadership:

It Has Everything To Do With the Practice of Law

Leadership development is studied at business schools and seminars throughout the country. Yet, poll the average attorney, and you would be hard pressed to find one who studied leadership as a course in law school. It is an unfortunate fact that most of us graduate having learned the basics in contract law, torts, and civil procedure (all relevant and necessary courses), but not in leadership skills, as being an effective leader and being an effective lawyer have much in

Within the first few years of practice, a lawyer is called upon to be a leader. We lead meetings with our clients and with personnel. We lead pro bono projects, summer associate programs, and by directing associates. The person who heads up a litigation team is often referred to as the "lead" counsel. Clients expect their lawyers to be leaders, because the attributes of a great lawyer and a great leader are often parallel.

positive attitude. A leader also has a vision for the future, a drive and commitment, and the skills, energy, and optimism to inspire others to achieve that vision. Leaders are forward-thinking, motivating, and determined. These traits and skills can be nurtured.

One of GAWL's five core goals in our current strategic plan is leadership--more specifically, to cultivate and energize the leader within women lawyers. To aid women lawyers in developing and At the most basic level, a leader enhancing their own leadership

skills, GAWL provides the opportunity for approximately 16 women each year to attend our Leadership Academy. In 2011, GAWL will hold its fourth annual Academy designed to train and support the appointment and promotion of qualified women lawyers to leadership positions. The committee will be seeking applications starting in mid-October from women lawyers who have at least six years in practice. The Academy will be held in February, March and April of 2011. Applications will be available on GAWL's website, www. gawl.org and at various GAWL events. Applications will be due November 30.

I encourage each of you to consider applying, and to look for other opportunities to develop, practice, and enhance your leadership skills throughout the year and throughout your practice.
